My PhD

- Topic: AI for radiotherapy quality assurance in clinical trials (experiments on humans) of head and neck cancers
- Supervised by a radiation oncologist (cancer doctor): Prof. Juliette Thariat
 - My 3rd semester internship supervisor during NucPhys
 - She offered the PhD after the internship
- Funded by two non-public organisations
 - Groupe d'Oncologie Radiothérapie Tête et Cou (Head and Neck Oncology and Radiotherapy Group): clinical trials and studies specific to head and neck cancers in France
 - AQUILAB by Coexya: products and services to aid radiotherapy quality assurance

Benefits of working with a company

Basically, the same as public, but a little bit more premium

- I get paid 2525 EUR before tax, while the public PhD was 2083 EUR when I started
 - ~1800 EUR net
 - My total monthly spending in Caen ~ 450 – 1000 EUR (gamma dist.)
 - Mine is fixed, while the public one is inflation-adjusted (2300 EUR in 2026)
- I have
 - Electric bike
 - 10 EUR lunch voucher per work day
 - Private retirement plan supported by the company
 - Private health care and insurance that could cover my immediate family
 - Limited but tax-free investment account
 - Childcare support

Additional requisites by the company

- I have two bosses with different interests
 - Company boss wants to make money
 - University boss wants to produce scientific value
- My contract requires a commercial product to be developed, as well as scientific outcomes
- My main contact is the university boss
- The company boss is more **professional**
- 28 days of holiday (almost half as some public PhDs)

Supervisor vs PhD in company

Your supervisor is **vital**

- **Do not think being able to work with a supervisor with a difficult character is a skill**
- Your supervisor must
 - Be easy to understand
 - Apply power tactfully
 - Not be super busy
- You can find out about a supervisor by:

 2. Email the ex-student about the supervisor
 3. **Do not ignore the strong warnings**

Summary

- Financial benefits and resources of a PhD with a company is the same as a public one, but a little more premium
- PhD with a company serves a stakeholder with a commercial interest besides scientific values
- ~~Öçham's~~ Özgür's razor: of two competing PhDs with and without private funding, the PhD with the simplest supervisor must be preferred
